MANNER OF PAYMENT:

All payments due under this Agreement of interest and principal shall be made in lawful money of the country of Canada on the date on which such payment is due by Direct Deposit to Mercenary Oilfield Services account at a bank specified by the Mercenary Oilfield Services.

Direct Deposit Information to be Supplied to Corporation. No Wire Transfer.

PAYMENT TERMS:

The Corporation shall reimburse Mercenary Oilfield Services for all reasonable expenses actually and properly incurred by the Mercenary Oilfield Services in the performance of the Services hereunder, provided that such expenses shall be evidenced by proper itemized invoices and further provided that such expenses are first approved by the Corporation. The Corporation shall, monthly, reimburse Mercenary Oilfield Services for all such expenses within 30 days after receipt by the Corporation of any invoices from the Mercenary Oilfield Services.

OVERDUE AMOUNTS

All overdue amounts owing to the Contractor hereunder, including, without limitation, all overdue Fees, amounts and expenses, shall accrue interest at the rate of 18% per annum starting after fees are due.
